

## Greene County CARES Act Relief Fund Advisory Council

This year the U.S. Senate passed the Coronavirus Relief Fund to provide direct funding to states, territories and tribal governments. The goal is to promote recovery by funding programs and services that support the needs of those impacted by COVID-19. As part of this fund, Greene County has received \$34.4 million to be distributed back into our community to help support local coronavirus response efforts.

To help ensure equitable allocation of these funds locally, the Greene County Commission has appointed a citizen advisory council from a diverse number of sectors to bring their expertise to the County's CARES Act Relief Fund application review and approval process.

### The CARES Act Relief Fund Advisory Council members are:



#### **Candace Adams, Emergency Management Retiree and Educator**

Adams is retired from both Greene County OEM and Missouri SEMA where she coordinated disaster mitigation, preparedness, response and recovery planning for 18 counties. She currently serves as an adjunct faculty member at University of Central Missouri in the Crisis and Disaster Management Bachelor degree program.



#### **Dr. Linda Barboa, Speech Language Pathologist**

Dr. Barboa, of Battlefield, most recently worked as a speech language pathologist at Springfield Public Schools. She is also the founder and executive director of STARS for Autism, a non-profit educational organization. Dr. Barboa has published numerous children's books and is a sought after speaker and presenter on successful approaches to assisting children with autism.

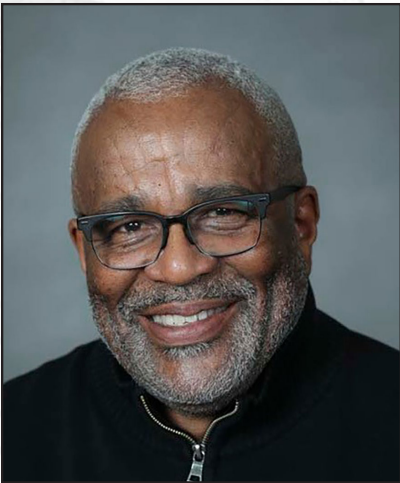
**Jill Stoner, Business Owner, Turners**
