Shall the Board of Education of the Ash Grove R-IV School District, Missouri, with no estimated increase in the current debt service property tax levy, borrow money in the amount of Three Million Eight Hundred Thousand Dollars (\$3,800,000) for the purpose of providing funds for the construction, equipping and furnishing of an office wing and computer lab at the high school to include a new entrance to enhance student security and safety; to complete renovation improvements to the high school gymnasium and other facilities consisting of restrooms, roofs, brick, soffits, gutters and other items; to construct, equip, and furnish additional classrooms and restrooms at the Bois D'Arc Elementary School; to construct, furnish, and/or renovate other school facilities to the extent funds are available; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at fifty cents (\$0.50) per one hundred dollars of assessed valuation of real and personal property.
