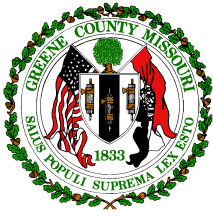
## **Greene County reminds visitors of campus parking, assembly locations**

SUBJECT: Disruptive Conduct and Soliciting, Canvassing, Pamphletting, Leafletting on Greene County Campus

**WHEREAS**, Section 49.270 RSMo. provides the County Commission with control and management of real property belonging to the Greene County; and this includes authority over buildings on the County campus;

**NOW, THEREFORE, BE IT ORDERED BY THE COUNTY COMMISSION OF GREENE COUNTY, MISSOURI, AS FOLLOWS:**

A) If an individual engages in disruptive conduct in any building on the County campus, or otherwise on the County campus, to the point of interfering with a Greene County employees' ability to conduct business, or to the point there is a legitimate basis to believe the individual poses a threat to the safety of Greene County employees and/or other individuals present, he or she may be ordered out of the building or off the County campus, or the Sheriff may be summoned and the disruptive individual removed from the County campus.

B) If a disruptive individual refuses to leave the County campus upon request of a Greene County employee, then such individual may be physically removed by the Sheriff and charged with a criminal offense under state law for willfully disobeying the order of a law enforcement officer.

C) All individuals and groups are prohibited from soliciting, peddling, and hawking; distributing leaflets, pamphlets, and literature; canvassing; picketing; circulating petitions; and wearing clothing, apparel, or other accessories containing disruptive or inflammatory language or content in the buildings on the County campus as it may disrupt the operations of County business on the County campus, impede traffic flow in and around County buildings, and present safety concerns.

D) Individuals and groups may solicit; distribute leaflets, pamphlets, and literature; canvass; picket; and circulate petitions on the County campus in the following designated areas:

- (1) The south front door steps and sidewalk to the street of the Historic Courthouse;
- (2) The public sidewalk along Boonville on the west side of the Historic Courthouse and the Judicial Center;


- (3) The public sidewalk along Central on the south side of the Historic Courthouse;  
and
- (4) The public sidewalk along Robberson on the east side of the Historic Courthouse.


E) If the behavior of any individual or group soliciting; distributing leaflets, pamphlets, and literature; canvassing; picketing; and circulating petitions on the County campus in the aforementioned designated areas becomes disruptive to the point of interfering with the County's ability to conduct its routine business, or to the point there is a legitimate basis to believe the individual poses a threat to the safety of Greene County employees and/or other individuals present or a dangerous situation exists, Greene County personnel may summon the Sheriff to assist in addressing such situation.

F) This Order revokes the Order regarding Solicitations on Greene County campus issued September 9, 1996.

This Order shall be in full force and effect from and after its passage.
