Personal and Business Property Assessment Lists - Second Notices

SPRINGFIELD, Mo. – Greene County Assessor Brent Johnson is urging all Greene County residents and business owners to submit their 2025 Personal and Business Property Assessment Lists before **May 1, 2025**, to avoid late assessment penalties.

Assessments not returned by the initial March 1 deadline are already considered late and subject to penalties. However, in accordance with Missouri statutes, the Assessor has the authority to waive late penalties if assessment lists are submitted before **May 1**.

Second notice postcards will be mailed on March 28th to **38,072 individuals** and **2,418 businesses** who have yet to file their assessment forms. The original assessment lists were distributed in early January.

"I want to ensure that everyone has the opportunity to submit their assessment lists by May 1 to avoid penalties, which can range from **\$15 to \$105**, depending on the assessed value," Johnson said.

How to File Your 2025 Personal or Business Assessment List:

- **Online:** File electronically via the Greene County Assessor's website at <https://greenecountymo.gov/assessor/>
- **By Mail:** Return the completed paper form to the Assessor's Office.
- **In Person:** File directly at the Assessor's Office.

Please note: Assessments cannot be completed by phone.

Make sure your list is signed, all unsigned lists will be returned and not accepted.

For individuals needing to assess property for tax years prior to 2025, please contact the Assessor's Office directly, as prior year assessments are not available through the online system.

Additionally, property and business owners may verify the receipt status of their 2025 assessment list through the Greene County Assessor's website. "My goal is to make the assessment process as smooth as possible for all property and business owners," Johnson said. "This online tool adds transparency by allowing users to check if their list has been received." Status updates are typically reflected within 24 hours of receipt by the Assessor's Office.

Under Missouri law (RSMo. Chapter 137), all Greene County residents and business owners as of January 1, 2025, are required to declare all taxable personal and business property to the Greene County Assessor. This includes, but is not limited to, motor vehicles, boats, trailers, livestock, farm machinery, and business-related equipment.

The information provided on the assessment lists will form the basis for calculating 2025 personal and business property tax bills, which will be issued by the Greene County Collector of Revenue in November 2025.
